April 2024 Meeting Minutes

**1. Open Meeting:** 7:03 p.m.

**2. Roll Call**

- a. **Club Officers:** Jeff W., Tammy W., Mac M., Rob O., Barb R., Bob R., Len T.

**3. Agenda Additions or Approval:** Len made a motion to approve the agenda as presented with corrections made. Rob seconded, all in favor, none opposed. Motion Carried.

**4. Approve Past Meeting Minutes:** Barb made a motion to approve the March 2024 minutes as published with correction made. Bob seconded, all in favor, none opposed. Motion Carried.

**5. Treasurer's Report/Approve Bills:** Checking Balance for April 2024 is \$10,555.69. Len made a motion to approve the Approved Bills and the Treasurer's Report as presented. Bob seconded, all in favor, none opposed. Motion Carried.
